The academic component of these posts will be based at the Primary Care Unit of the Cambridge University Department of Public Health & Primary Care. The clinical posts will be based in general practices and hospitals in the greater Cambridge area. They provide an exciting balance of clinical and research training and carry an academic training number – NTN(A). The Academic Clinical Fellowship extends general practice training by one year to allow the successful candidate to spend the equivalent of one year in academic primary care. This will usually entail completion of a Masters in Primary Care Research, and end with the candidate being in a position to make a competitive application for a national doctoral training award.

The primary care unit has world-class strengths in the core subjects that underpin academic general practice and applied research, including health services research, behavioural science, health psychology, social science and clinical trials.

Eligibility Criteria for recruitment to Specialty Training 2016 – Immigration Requirements

UK and EEA nationals and doctors whose immigration status entitles them to work as a doctor in training in the UK are eligible to apply for specialty training. Evidence of immigration status would be a biometric residence card, date stamped passport and/or identity card. All of these documents need to be dated as at or prior to the application closing date.

Doctors who are not UK or EEA nationals but whose immigration status entitles them to work without restriction in the UK will be considered on an equal basis with UK and EEA nationals. Other non-UK or non-EEA nationals with limited leave to remain in the UK and whose employment will require Tier 2 sponsorship are subject to the Resident Labour Market Test (RLMT). Applicants who are subject to RLMT will not be eligible for appointment in this specialty until all suitably qualified, experienced and skilled EU/EEA candidates have been appointed and the Resident Labour Market Test has been satisfied. The RLMT will not be satisfied in Round 1 of recruitment so applicants to which the RLMT applies are strongly advised to pursue their applications in Round 2 of recruitment.
