#### Introduction

Institutions around the UK provide a wide choice of courses relating to public health and health and wellbeing. These courses can usually be studied full-time or part-time, taken in the workplace (with the support of your employer), at colleges and universities, or by distance-learning at home in your spare time.

This document has been commissioned by Health Education Thames Valley to provide an insight into the range of courses available to support public health development. The courses have been identified as a consequence of a desk top review. No attempt has been made to quality assure the content of the courses. This is not a definitive directory of all the courses which are available – it is constantly being developed and updated. #### **Public Health: levels of practice**

The following three categories of public health workers are widely accepted as constituting the public health workforce:

- **Public Health specialists**: consultants in public health and specialists in public health who work at a strategic or senior management level or at a senior level of scientific expertise to influence the health of the whole population or of a selected community.
- Public health practitioners: those who spend a major part, or all, of their time in public health practice e.g. public health information analyst, oral health promoter, smoking cessation coordinator, health visitor etc.
- Wider public health: most people, including managers, have a role in health improvement and reducing health inequalities although they may not recognise this, including: teachers, social workers, local business leaders, transport engineers, town planners, housing officers, regeneration managers and so on. <sup>1</sup>

This document has deliberately taken a broad focus, in order to identify courses which may be relevant at each of these workforce levels.

# Courses likely to be more relevance for those seeking formal qualifications/registration for practitioner level practice<sup>2</sup>

#### The public health practitioner scheme

Thames Valley is currently operating a scheme to support practitioners to achieve professional registration with the UKPHR. Registration is achieved through completion of a retrospective portfolio to demonstrate how you meet the UKPHR professional competences for registration at level 5 (the minimum level for practice). Access to the scheme is competitive. Practitioners requesting support through the Thames Valley Practitioner Scheme are expected to be able to demonstrate:

- 2 years' experience in public health, usually having occupied a public health practitioner post at NHS Agenda for Change band 5 -7 or equivalent in other sectors;
- operating at Level 5 or above on the Public Health Skills & Knowledge Framework
- employment in the Thames Valley region
- Full support of your Line Manager and employing organisation.

Practitioners on the Scheme are supported through facilitated learning sets in priority areas of Continuing Professional Development (CPD) to enable them to complete a portfolio of evidence of competence against the UKPHR practitioner standards. Each practitioner attends up to 4 facilitated learning sets, where they are supported in preparing their portfolio and receive one-to-one feedback on progress. Peer support is crucial, with the practitioners very much benefiting from sharing their work with each other and talking through any concerns. Practitioners are assigned a UKPHR trained assessor.

#### Masters in Public health (MPH)

#### **Subject description**

Typically, this course is concerned with how to improve the health of populations, communities and particular groups within them through the promotion of health and prevention of diseases; the provision and evaluation of treatment and care; and the investigation and control of environmental threats to health.

## **Specialty training**

The standard training route to become a public health specialist is through the Faculty of Public Health's higher specialist training programme. Public Health training usually lasts five years, full-time. Part-time training is proportionately longer. The five years usually includes one year (full) on an academic course, and 48 months in higher specialist training posts.

Recruitment opens in the autumn and will be announced on the recruitment section of the Faculty of Public Health Website, www.fph.org.uk/recruitment and Thames Valley Health Education England, www.thamesvalley.hee.nhs.uk.

Recruitment for public health is managed nationally with applicants making a single application with expressed preference for specific programmes and geographical zones. Assessment and selection is standardised across several centres in the UK. The programme is open to candidates from medical and non-medical backgrounds according to nationally agreed eligibility criteria.
