	Professor Bill Irish will be your Responsible Officer. HEE, EoE will be	
	your Designated Body .	
	Revalidation – As you are aware, all fully licensed doctors	
	are required to revalidate, usually every 5 years and in any	
	event, when you are ready to be awarded your CCT.	
3	If you have had an ARCP or NHS appraisal prior to starting your training	
	with HEE, EoE you must submit a copy of your latest ARCP Outcome	
	form or NHS appraisal. This information must be provided by the time	
	you take up your training post to edit.eoe@hee.nhs.uk . Failure to do	
	so will affect your revalidation.
