Population Health: Promoting Health and Preventing Disease Summary

The role of the GP in promoting health and preventing disease

The defining role of the GP is enacted in the consultation with the patient. However, GPs also have an essential role in the health of communities. Optimising the public's health requires coordination across three areas: health improvement, health protection, and health services.

As a GP, your role is to:

- Take part in all three of these areas, for example by promoting healthy living, delivering screening and immunisation programmes, and using resources and services appropriately
- Understand the social determinants of health, from pre-birth to old age
- Assess the needs of local population groups
- Advocate for measures that promote good health in populations as well as individuals
- Address health inequalities
- Assess and communicate risk.
