A Message from the Associate Dean for SAS/LEDs'

The Newsletter was temporarily discontinued in 2022 due to circumstances beyond our control. I am delighted to say that we are now able to re-start publication of this important communication tool which will be circulated electronically every four months. The support for The Newsletter was 89% in the SAS 2024 survey.

East of England (EOE) SAS Annual Survey is one of the key activities which provides information on the needs of SAS doctors in the region. The EOE annual development programme is strongly influenced by the views expressed by SAS doctors who participate in the surveys. The survey showed that "bullying & undermining" is being experienced by a significant number of SAS doctors in EoE (25%). These are worrying statistics and SAS doctors and SAS Tutors need to share the results with the LNC leads and their Trust's senior leadership.

East of England "SAS Trainer of the Year Awards" are being restarted. Please await nomination forms which will be circulated soon and the deadline for nominations announced. There will be an opportunity to self-nominate. The winning nominations will be announced at the EoE SAS Steering Group meeting in October 2024.

Demonstrating a yearon-year continued improvement in the response rate, the SAS survey outcomes have helped to shape the future of the educational programmes.

This year the survey was completed by 255 SAS doctors, and although this still does not represent the majority of our SAS Doctors, it is positive to see more involvement. Thanks to those who, despite their busy jobs, took the time to share their views. The survey provided important insight into several aspects of SAS doctors' working lives. Apart from other aspects it highlighted the fact that many recommendations of the SAS Charter have not been fully implemented. This view is shared by the majority of SAS doctors.
