Keynote

How the new Medical Schools are different

In this session Sanjiv Ahluwalia will explore the reasons for creating new medical schools, and using Anglia Ruskin as an example, showcase how new medical schools may add value to healthcare systems.

Dr Sanjiv Ahluwalia

Sanjiv Ahluwalia is a General Medical Practitioner. He has a special interest in understanding the influence of clinical education on patient care.

Sanjiv graduated from the University of London (Medical Schools of Guys and St Thomas's) in 1994. He completed his training as a General Medical Practitioner at the Royal Free Hospital and Barnet Vocational Training Scheme in 2000. He has worked as a GP in Barnet since 1999.

Sanjiv has been involved in clinical education since 2002 having started as a GP training programme director and most recently has been the Regional Postgraduate Dean for London. His educational work has consisted of managing postgraduate medical training programmes, workforce, and educational transformation with service providers, and developing interprofessional education. His research explores the relationship between clinical education and patient care/outcomes.

Research interests:

- -Clinical education and patient outcomes
- -Population health management
- -Relational ethics in Primary Care

Sanjiv has developed an interest in the relationship between clinical education and patient outcomes in primary care. Using quantitative and qualitative methods, he has explored the nature of the relationship between the two. His work has demonstrated that education clinically and statistically influences care for better patient outcomes. Further work is underway to delineate the direction of influence and better understand the economic benefits associated with this.

Most ethics teaching in medical schools follows the work of Beauchamp and Childress. Working with colleagues, he has recently started to explore the applicability of principlism in primary care.

Workshops 1

Blended Learning - How to set up a Blended Learning Fellowship Programme

Deep End England - What is the Deep End? How can we support those most at risk?

Since the 2010 Marmot review, tax & benefit reforms have widened income & wealth inequalities, and government spending has decreased most in the most deprived areas. Those who face such socio-economic challenges are at increased risk of severe disease, early in life. Those who face Adverse Child & Community Events (ACEs) are also at increased risk of severe disease & disrupted neurodevelopment. Such groups of patients are known as 'Deep End Patients'. This workshop will describe how the 'Deep End' affects our patients, and how they engage with healthcare, and more importantly how we should respond as clinicians & organisations to ensure trauma-informed care is offered.

Jessica launched Deep End: East of England in September 2021, connecting those individuals & practices who are serious about improving the health & well-being of those communities who live in our most deprived areas, or face the most challenging socioeconomic circumstances. There are now Deep End networks in each of the six ICS' across EoE, seeking to support health& care organisations intentionally mitigate health inequalities, based the established expertise & experience of our Deep End Colleagues in Scotland & across the UK.

Innovative ways we used our Covid Recovery Funding

Subir is a GP Training Programme Director, Chelmsford GP Training Programme. Subir joined the PSW as a Clinical Case Manager in March 2021 at the height of the second wave of the pandemic.

The new RCGP SCA exam: What we know so far

This is a summary of what we know so far about the RCGP Simulated Consultation Assessment, which will soon replace the current CSA exam.

Avanti Sulakshana

Avanti was appointed Associate Dean Of Exam Support in March 2023. She has worked as a GP Partner since the start of her career in 2005 at Barton-Le Clay in Bedfordshire. She became a GP Trainer and a Training Program Director for the Luton VTS in 2008. In October 2020 she left the Luton VTS TPD role to work as the TPD for Differential Attainment and Quality for the BLMK region. She spent a year supporting both Bedford and Luton schemes during the redesign of the GPST training. Her role included liaising with Hospital, General Practice, and deanery workforce teams to ensure rotations were constructed were fit for purpose and aligned to the training requirements of GP Trainees. During this period, she also supported the two VTS programs in delivering teaching to their GPSTs. In September 2022, she started her work as an Exam Support TPD for BLMK where she stayed until moving into the AD role in March 2023. Her main interest throughout her career has been around differential attainment in IMGs. Her MA dissertation in 2013: 'Culture, Pedagogy and Medicine: How GP educators negotiate the challenges faced by international medical graduates', helped her further explore this arena with local Educators to enhance IMG training in Luton.

Avanti spends a large part of her time pursuing various sporting activities like running, badminton, golf etc. She is a frequent volunteer at Luton Parkrun, a local community initiative. She is also very interested in Lifestyle Medicine and NLP and is currently furthering that interest by trying to acquire formal qualifications in those areas.

GMC led Q&A session with Educators

The GMC sets the standards for the delivery of medical education and training by medical schools and postgraduate training organisations (PTOs) as outlined in Promoting excellence: standards for medical education and training.

To give us oversight of how HEE EoE meets these standards, we ask HEE EoE to submit an annual self-assessment questionnaire (SAQ) explaining how they meet our standards. We then carry out quality activities for triangulation of their responses. Activities include question-and-answer sessions with a variety of stakeholder groups.

HEE EoE told us about their processes on how local education providers (LEPs) are supported for teaching and delivery in the learning environment. As such, we would like to meet with LEP management teams on Wednesday 26 April 2023 for some question-and-answer sessions. The purpose of these meetings is to ask a variety of questions, covering various themes, to capture your experience and interactions with HEE EoE. We're attending this activity to assess how HEE EoE meets our standards, so it's important for you to note we will not be assessing a trust or an individual's performance in any way.

It's important that we hear your views, both positive and negative, on your experience. We want you to be open with us; this is an opportunity for you to tell us about any changes you feel should be made, or to praise elements which you feel deserve recognition.

Although we'll record what you tell us, we won't make your comments attributable. If a disclosure is made during the sessions that could present an immediate risk to patient or learner safety, then we'll need to raise this directly with HEE EoE so that the concern can be followed up sooner than via our written feedback.
